Counterfactuals and dependencies on causal teams: expressive power and deduction systems

Abstract

We analyze the causal-observational languages that were introduced in Barbero and Sandu (2018), which allow discussing interventionist counterfactuals and functional dependencies in a unified framework. In particular, we systematically investigate the expressive power of these languages in causal team semantics, and we provide complete natural deduction calculi for each language. As an intermediate step towards the completeness, we axiomatize the languages over a generalized version of causal team semantics, which turns out to be interesting also in its own right.

Keywords: Interventionist counterfactuals, causal teams, dependence logic, team semantics.

1 Introduction

Counterfactual conditionals express the modality of *irreality*: they describe what *would* or *might* be the case in circumstances which diverge from the actual state of affairs. Pinning down the exact meaning and logic of counterfactual statements has been the subject of a large literature (see e.g. [15]). We are interested here in a special case: the *interventionist* counterfactuals, which emerged from the literature on causal inference ([14,13,11]). Under this reading, a conditional $\mathbf{X} = \mathbf{x} \longrightarrow \psi$ states that ψ would hold if we were to intervene on the given system, by subtracting the variables \mathbf{X} to their current causal mechanisms and forcing them to take the values \mathbf{x} .

The logic of interventionist counterfactuals has been mainly studied in the semantical context of $deterministic \ causal \ models$ ([7,8,3,19]), which consist

of an assignment of values to variables together with a system of *structural* equations that describe the causal connections. In [1], causal models were generalized to causal teams, in the spirit of team semantics ([12,16]), by allowing a set of assignments (a "team") instead of a single assignment. This opens the possibility of describing e.g. uncertainty, observations, and dependencies.

One of the main reasons for introducing causal teams was the possibility of comparing the logic of dependencies of causal nature (those definable in terms of interventionist counterfactuals) against that of contingent dependencies (such as those studied in the literature on team semantics, or in database theory) in a unified semantic framework. [1,2] give anecdotal evidence of the interactions between the two kinds of dependence, but offer no general axiomatizations for languages that also involve contingent dependencies. In this paper we fill this gap in the literature by providing complete deduction systems (in natural deduction style) for the languages COD and $CO_{\mathbb{W}}$ (from [1]), which enrich the basic counterfactual language CO, respectively, with atoms of functional dependence =(\mathbf{X} ; Y) ("Y is functionally determined by \mathbf{X} "), or with the intuitionistic disjunction \mathbb{W} , in terms of which functional dependence is definable. We also give semantical characterizations, for COD, $CO_{\mathbb{W}}$ and the basic counterfactual language CO, in terms of definability of classes of causal teams.

The strategy of the completeness proofs is the following. We introduce a generalized causal team semantics, which encodes uncertainty over causal models, not only over assignments. (This semantics is used as a tool towards completeness, but also has independent interest.) We then prove completeness results for this semantics, by incorporating techniques developed in [17,5] for the pure (non-causal) team context. Finally, we extend the calculi to completeness over causal teams by adding axioms which capture the property of being a causal team (i.e. encoding certainty about the causal connections).

The paper is organized as follows. Section 2 introduces the formal languages and two kinds of semantics. Section 3 deepens the discussion of the functions which describe causal mechanisms, addressing issues of definability and the treatment of dummy arguments. Section 4 characterizes semantically the language CO and reformulates in natural deduction form the CO calculi that come from [2]. Section 5 gives semantical characterizations for COD and $CO_{\mathbb{W}}$, and complete natural deduction calculi for both kinds of semantics.

2 Syntax and semantics

2.1 Formal languages

Let us start by fixing the syntax. Each of the languages considered in this paper is parametrized by a (finite) **signature** σ , i.e. a pair (Dom, Ran), where Dom is a nonempty finite set of **variables**, and Ran is a function that associates to each variable $X \in \text{Dom a nonempty finite set Ran}(X)$ (called the **range** of X) of **constant symbols** or **values**. We reserve the Greek letter σ for signatures.

We use a boldface capital letter **X** to stand for a sequence $\langle X_1, \ldots, X_n \rangle$ of variables; similarly a boldface lower case letter **x** stands for a sequence $\langle x_1, \ldots, x_n \rangle$ of values. We will sometimes abuse notation and treat **X** and **x** as sets. We write $\text{Ran}(\mathbf{X}) = \text{Ran}(X_1) \times \cdots \times \text{Ran}(X_n)$.

Now fix a signature $\sigma = (Dom, Ran)$. An atomic σ -formula is an equation X = x, where $X \in Dom$ and $x \in Ran(X)$. The conjunction of n equations $(\dots((X_1 = x_1 \land X_2 = x_2) \land X_3 = x_3) \land \dots \land X_{n-1} = x_{n-1}) \land X_n = x_n$ is abbreviated as $X_1 = x_1 \land \dots \land X_n = x_n$ or further as $\mathbf{X} = \mathbf{x}$, and is also called an equation. Compound formulas of the basic language $CO[\sigma]$ are formed by the grammar:

$$\alpha ::= X = x \mid \neg \alpha \mid \alpha \land \alpha \mid \alpha \lor \alpha \mid \mathbf{X} = \mathbf{x} \longrightarrow \alpha$$

where $\mathbf{X} \cup \{X\} \subseteq \mathrm{Dom}, \ x \in \mathrm{Ran}(X), \ \mathbf{x} \in \mathrm{Ran}(\mathbf{X})$. The connective $\square \to$ is used to form interventionist counterfactuals. We abbreviate $\neg (X = x)$ as $X \neq x$, and $X = x \wedge X \neq x$ as \bot . Throughout the paper, we reserve the first letters of the Greek alphabet, α, β, \ldots for $CO[\sigma]$ -formulas.

Let us compare our language $CO[\sigma]$ with the existing interventionist counterfactual languages in the literature. The original formulation of $CO[\sigma]$ in [1,2] includes in the syntax another conditional \supset , called *selective implication*, which can be defined in our setting in terms of negation and disjunction as $\alpha \supset \beta := \neg \alpha \lor \beta$. Our primitive connective negation \neg was treated in [1,2] as a defined connective. The language $CO[\sigma]$ as defined here can also be seen as the fragment of the language considered by Briggs in [3] in which occurrences of \lor and \neg are not allowed in the antecedents of $\Box \rightarrow$. Differently from the language for counterfactuals defined by Halpern in [9], in our language $CO[\sigma]$ nesting of counterfactuals to the right of $\Box \rightarrow$ is allowed (i.e., in $\mathbf{X} = \mathbf{x} \Box \rightarrow \alpha$, α can still contain counterfactuals), and any type of variables (exogenous or endogenous) can occur in the antecedents of counterfactuals (i.e., in $\mathbf{X} = \mathbf{x}$) as we do not distinguish exogenous and endogenous variables in the signature σ .

We study in this paper also two extensions of $CO[\sigma]$, obtained by adding the *intuitionistic disjunction* \mathbb{V} , or the dependence atoms =(X; Y):

- $CO_{\mathbb{V}}[\sigma] : \varphi ::= X = x \mid \neg \alpha \mid \varphi \land \varphi \mid \varphi \lor \varphi \mid \varphi \lor \varphi \mid \mathbf{X} = \mathbf{X} \longrightarrow \varphi$
- $COD[\sigma]$: $\varphi ::= X = x \mid =(X; Y) \mid \neg \alpha \mid \varphi \land \varphi \mid \varphi \lor \varphi \mid X = x \Longrightarrow \varphi$

Note that we only allow the negation \neg to occur in front of $CO[\sigma]$ -formulas.

2.2 Causal teams

We now define the team semantics of our logics over causal teams. We first recall the definition of causal teams adapted from [2].

Fix a signature $\sigma = (\text{Dom}, \text{Ran})$. An **assignment** over σ is a mapping $s : \text{Dom} \to \bigcup_{X \in \text{Dom}} \text{Ran}(X)$ such that $s(X) \in \text{Ran}(X)$ for each $X \in \text{Dom}$. 4 Denote by \mathbb{A}_{σ} the set of all assignments over σ . A **team** T over σ is a set of assignments

result in more general completeness results.

over σ , i.e., $T \subseteq \mathbb{A}_{\sigma}$.

A system of functions \mathcal{F} over σ is a function that assigns to each variable V in a domain $\operatorname{En}(\mathcal{F}) \subseteq \operatorname{Dom}$ a set $PA_V^{\mathcal{F}} \subseteq \operatorname{Dom} \setminus \{V\}$ of **parents** of V, and a function $\mathcal{F}_V : \operatorname{Ran}(PA_V^{\mathcal{F}}) \to \operatorname{Ran}(V)$. So Variables in the set $\operatorname{En}(\mathcal{F})$ are called **endogenous variables** of \mathcal{F} , and variables in $\operatorname{Ex}(\mathcal{F}) = \operatorname{Dom} \setminus \operatorname{En}(\mathcal{F})$ are called **exogenous variables** of \mathcal{F} .

Denote by \mathbb{F}_{σ} the set of all systems of functions over σ , which is clearly finite. We say that an assignment $s \in \mathbb{A}_{\sigma}$ is **compatible** with a system of functions $\mathcal{F} \in \mathbb{F}_{\sigma}$ if for all endogenous variables $V \in \text{En}(\mathcal{F})$, $s(V) = \mathcal{F}_{V}(s(PA_{V}^{\mathcal{F}}))$.

Definition 2.1 A causal team over a signature σ is a pair $T = (T^-, \mathcal{F})$ consisting of

- a team T^- over σ , called the **team component** of T,
- and a system of functions \mathcal{F} over σ , called the **function component** of T, where all assignments $s \in T^-$ are compatible with the function component \mathcal{F} .

Any system $\mathcal{F} \in \mathbb{F}_{\sigma}$ of functions can be naturally associated with a (directed) graph $G_{\mathcal{F}} = (\text{Dom}, E_{\mathcal{F}})$, defined as $(X,Y) \in E_{\mathcal{F}}$ iff $X \in PA_Y^{\mathcal{F}}$. We say that \mathcal{F} is **recursive** if $G_{\mathcal{F}}$ is acyclic, i.e., for all $n \geq 0$, $E_{\mathcal{F}}$ has no subset of the form $\{(X_0, X_1), (X_1, X_2), \dots, (X_{n-1}, X_n), (X_n, X_0)\}$. The graph of a causal team T, denoted as G_T , is the associated graph of its function component. We call T **recursive** if G_T is acyclic. Throughout this paper, for simplicity we assume that all causal teams that we consider are recursive.

Intuitively, a causal team T may be seen as representing an assumption concerning the causal relationships among the variables in Dom (as encoded in \mathcal{F}) together with a range of hypotheses concerning the actual state of the system (as encoded in T^-). We now illustrate this idea in the following example.

Example 2.2 The following diagram illustrates a causal team $T = (T^-, \mathcal{F})$.

$$T^{-}: \begin{array}{|c|c|c|} \hline U \rightarrow X \rightarrow Y \rightarrow Z \\ \hline 0 & 0 & 1 & 2 \\ \hline 1 & 1 & 2 & 6 \end{array} \qquad \begin{cases} \mathcal{F}_X(U) &= U \\ \mathcal{F}_Y(X) &= X+1 \\ \mathcal{F}_Z(X,Y,U) &= 2*Y+X+U \end{cases}$$

The table on the left represents a team T^- consisting of two assignments, each of which is tabulated in the obvious way as a row in the table. For instance, the assignment s of the first row is defined as s(U) = s(X) = 0, s(Y) = 1 and s(Z) = 2. The arrows in the upper part of the table represent the graph G_T of the causal team T. For instance, the arrow from U to Z represents the edge (U,Z) in G_T . The graph contains no cycles, thus the causal team T is recursive. The variable U with no incoming arrows is an exogenous variable. The other variables are endogenous variables, namely, $En(\mathcal{F}) = \{X, Y, Z\}$. The function component is determined by the system of functions on the right of the above diagram. Each equation defines the "law" that generates the values of an endogenous variable.

Let $S = (S^-, \mathcal{F})$ and $T = (T^-, \mathcal{G})$ be causal teams over the same signature. We call S a **causal subteam** of T, denoted as $S \subseteq T$, if $S^- \subseteq T^-$ and $\mathcal{F} = \mathcal{G}$.

An equation $\mathbf{X} = \mathbf{x}$ is said to be **inconsistent** if it contains two conjuncts X = x and X = x' with distinct values x, x'; otherwise it is said to be **consistent**.

Definition 2.3 (Intervention) Let $T = (T^-, \mathcal{F})$ be a causal team over some signature $\sigma = (\text{Dom}, \text{Ran})$. Let $\mathbf{X} = \mathbf{x} (= X_1 = x_1 \wedge \cdots \wedge X_n = x_n)$ be a consistent equation over σ . The intervention $do(\mathbf{X} = \mathbf{x})$ on T is the procedure that generates a new causal team $T_{\mathbf{X}=\mathbf{x}} = (T^-_{\mathbf{X}=\mathbf{x}}, \mathcal{F}_{\mathbf{X}=\mathbf{x}})$ over σ defined as follows:

- $\mathcal{F}_{X=x}$ is the restriction of \mathcal{F} to $\text{En}(\mathcal{F}) \setminus X$,
- $T_{\mathbf{X}=\mathbf{x}}^- = \{s_{\mathbf{X}=\mathbf{x}} \mid s \in T^-\}$, where each $s_{\mathbf{X}=\mathbf{x}}$ is an assignment compatible with $\mathcal{F}_{\mathbf{X}=\mathbf{x}}$ defined (recursively) as

$$s_{\mathbf{X}=\mathbf{x}}(V) = \begin{cases} x_i & \text{if } V = X_i, \\ s(V) & \text{if } V \notin \operatorname{En}(T) \cup \mathbf{X}, \\ \mathcal{F}_V(s_{\mathbf{X}=\mathbf{x}}(PA_V^{\mathcal{F}})) & \text{if } V \in \operatorname{En}(T) \setminus \mathbf{X} \end{cases}$$

Example 2.4 Recall the recursive causal team T in Example 2.2. By applying the intervention do(X = 1) to T, we obtain a new causal team $T_{X=1} = (T_{X=1}^-, \mathcal{F}_{X=1})$ as follows. The function component $\mathcal{F}_{X=1}$ is determined by the equations:

$$\begin{cases} (\mathcal{F}_{X=1})_Y(X) &= X+1\\ (\mathcal{F}_{X=1})_Z(X,Y) &= 2*Y+X+U \end{cases}$$

The endogenous variable X of the original team T becomes exogenous in the new team $T_{X=1}$, and the equation $\mathcal{F}_X(U) = U$ for X is now removed. The new team component $T_{X=1}^-$ is obtained by the rewriting procedure illustrated below:

In the first step, rewrite the X-column with value 1. Then, update (recursively) the other columns using the functions from $\mathcal{F}_{X=1}$. In this step, only the columns that correspond to "descendants" of X will be modified, and the order in which these columns should be updated is completely determined by the (acyclic) graph $G_{T_{X=1}}$ Since the variable X becomes exogenous after the intervention, all arrows pointing to X have to be removed, e.g., the arrow from U to X. We refer the reader to [2] for more details and justification for this rewriting procedure.

Definition 2.5 Let φ be a formula of the language $CO_{\mathbb{V}}[\sigma]$ or $COD[\sigma]$, and $T = (T^-, \mathcal{F})$ a causal team over σ . We define the satisfaction relation $T \models^c \varphi$ (or simply $T \models \varphi$) over causal teams inductively as follows:

- $T \models X = x \iff for \ all \ s \in T^-, \ s(X) = x.^6$
- $T \models \exists (X; Y) \iff for \ all \ s, s' \in T^-, \ s(X) = s'(X) \ implies \ s(Y) = s'(Y).$

- $T \models \neg \alpha \iff for \ all \ s \in T^-, (\{s\}, \mathcal{F}) \not\models \alpha.$
- $T \models \varphi \land \psi \iff T \models \varphi \text{ and } T \models \psi.$
- $T \models \varphi \lor \psi \iff there \ are \ two \ causal \ subteams \ T_1, T_2 \ of \ T \ such \ that \ T_1^- \cup T_2^- = T^-, \ T_1 \models \varphi \ and \ T_2 \models \psi.$
- $T \models \varphi \lor \psi \iff T \models \varphi \text{ or } T \models \psi.$
- $T \models \mathbf{X} = \mathbf{x} \longrightarrow \varphi \iff \mathbf{X} = \mathbf{x} \text{ is inconsistent or } T_{\mathbf{X}=\mathbf{x}} \models \varphi.$

We write a dependence atom =(;X) with an empty first component as =(X). The semantic clause for =(X) reduces to:

• $T \models =(X)$ iff for all $s, s' \in T^-$, s(X) = s'(X).

Intuitively, the atom =(X) states that X has a constant value in the team. It is easy to verify that dependence atoms are definable in $CO_{\mathbb{V}}[\sigma]$:

$$=(Y) \equiv \bigvee_{y \in \operatorname{Ran}(Y)} Y = y \quad \text{and} \quad =(\mathbf{X}; Y) \equiv \bigvee_{\mathbf{x} \in \operatorname{Ran}(\mathbf{X})} (\mathbf{X} = \mathbf{x} \land =(Y)). \tag{1}$$

It is easy to verify that the *selective implication* $\alpha \supset \varphi := \neg \alpha \lor \varphi$, introduced originally in [1], has the same semantic clause as that in [1]:

• $T \models \alpha \supset \varphi \iff T^{\alpha} \models \varphi$, where T^{α} is the (unique) causal subteam of T with team component $\{s \in T^{-} \mid \{s\} \models \alpha\}$.

Example 2.6 Consider the causal team T and the intervention do(X = 1) from Examples 2.2 and 2.4. Clearly, $T_{X=1} \models Y = 2$, and thus $T \models X = 1 \Longrightarrow Y = 2$. We also have that $T \models = (Y; Z)$, while $T_{X=1} \not\models = (Y; Z)$ (contingent dependencies are not in general preserved by interventions). Observe that $T \models Y \neq 2 \lor Y = 2$, while $T \not\models Y \neq 2 \lor Y = 2$.

2.3 Generalized causal teams

We introduce here a more general semantics, which will be needed as a tool towards the completeness results for $CO_{\mathbb{N}}$ and COD.

Given a signature σ , write

$$\mathbb{S}em_{\sigma} := \{(s, \mathcal{F}) \in \mathbb{A}_{\sigma} \times \mathbb{F}_{\sigma} \mid s \text{ is compatible with } \mathcal{F}\}.$$

The pairs $(s, \mathcal{F}) \in \mathbb{S}em_{\sigma}$ can be easily identified with the deterministic causal models (also known as deterministic structural equation models) that are considered in the literature on causal inference ([14],[13], etc.). One can informally identify a causal team $T = (T^-, \mathcal{F})$ with the set

$$T^g = \{(s, \mathcal{F}) \in \mathbb{S}em_{\sigma} \mid s \in T^-\}$$

of deterministic causal models with a uniform function component \mathcal{F} throughout the team. In this section, we introduce a more general notion of causal team, called *generalized causal team*, where the function component \mathcal{F} does not have to be constant thoroughout the team.

Definition 2.7 A generalized causal team T over a signature σ is a set of pairs $(s, \mathcal{F}) \in \mathbb{S}em_{\sigma}$, that is, $T \subseteq \mathbb{S}em_{\sigma}$.

Intuitively, a generalized causal team encodes uncertainty about which causal model governs the variables in Dom - i.e., uncertainty both on the values of the variables and on the laws that determine them. Our interest in such models here is purely technical, but probabilistic variants of them have been used e.g. to define formal notions of blame ([4,9,10]).

Distinct elements (s, \mathcal{F}) , (t, \mathcal{G}) of the same generalized causal team may also disagree on what is the set of endogenous variables, or on whether the system is recursive or not. A generalized causal team is said to be **recursive** if, for each pair (s, \mathcal{F}) in the team, the associated graph $G_{\mathcal{F}}$ is recursive. In this paper we only consider recursive generalized causal teams.

For any generalized causal team T, define the **team component** of T to be the set $T^- := \{s \mid (s, \mathcal{F}) \in T \text{ for some } \mathcal{F}\}$. A **causal subteam** of T is a subset S of T, denoted as $S \subseteq T$. The **union** $S \cup T$ of two generalized causal teams S, T is their set-theoretic union.

A causal team T can be identified with the generalized causal team T^s , which has a constant function component in all its elements. Conversely, if T is a nonempty generalized causal team in which all elements have the same function component \mathcal{F} , i.e., $T = \{(s,\mathcal{F}) \mid s \in T^-\}$, we can naturally identify T with the causal team

$$T^c = (T^-, \mathcal{F}).$$

In particular, a singleton generalized causal team $\{(s,\mathcal{F})\}$ corresponds to a singleton causal team $(\{s\},\mathcal{F})$. Applying a (consistent) intervention $do(\mathbf{X}=\mathbf{x})$ on $(\{s\},\mathcal{F})$ generates a causal team $(\{s_{\mathbf{X}=\mathbf{x}}\},\mathcal{F}_{\mathbf{X}=\mathbf{x}})$ as defined in Definition 2.3. We can then define the result of the intervention $do(\mathbf{X}=\mathbf{x})$ on $\{(s,\mathcal{F})\}$ to be the generalized causal team $(\{s_{\mathbf{X}=\mathbf{x}}\},\mathcal{F}_{\mathbf{X}=\mathbf{x}})^g = \{(s_{\mathbf{X}=\mathbf{x}},\mathcal{F}_{\mathbf{X}=\mathbf{x}})\}$. Interventions on arbitrary generalized causal teams are defined as follows.

Definition 2.8 (Intervention over generalized causal teams) Let T be a (recursive) generalized causal team, and $\mathbf{X} = \mathbf{x}$ a consistent equation over σ . The intervention $do(\mathbf{X} = \mathbf{x})$ on T generates the generalized causal team $T_{\mathbf{X}=\mathbf{x}} := \{(s_{\mathbf{X}=\mathbf{x}}, \mathcal{F}_{\mathbf{X}=\mathbf{x}}) \mid (s,\mathcal{F}) \in T\}.$

Definition 2.9 Let φ be a formula of the language $CO_{\mathbb{V}}[\sigma]$ or $COD[\sigma]$, and T a generalized causal team over σ . The satisfaction relation $T \models^g \varphi$ (or simply $T \models \varphi$) over generalized causal teams is defined in the same way as in Definition 2.5, except for slight differences in the following clauses:

- $T \models^g \neg \alpha$ iff for all $(s, \mathcal{F}) \in T$, $\{(s, \mathcal{F})\} \not\models \alpha$.
- $T \models^g \varphi \lor \psi$ iff there are two generalized causal subteams T_1, T_2 of T such that $T_1 \cup T_2 = T$, $T_1 \models \varphi$ and $T_2 \models \psi$.

Example 2.10 Consider two function components \mathcal{F}, \mathcal{G} over the domain $Dom = \{X, Y, Z\}$ with Z the only endogenous variable, and $\mathcal{F}_Z(X) = 2 * X$ and $\mathcal{G}_Z(X,Y) = X + Y$. Clearly, $\mathcal{F} \neq \mathcal{G}$ as, e.g., the graph of \mathcal{G} contains an additional arrow from X to Z. Consider the generalized causal team $T = \{(s,\mathcal{F}), (s,\mathcal{G}), (t,\mathcal{G})\}$, represented in the following left table:

$T_{Y=1}$:	X	Y	Z	
	2	1	4	$\mathcal{F}_{Y=1}$
	2	1	3	$G_{Y=1}$
	1	1	2	$\mathcal{G}_{Y=1}$

Since both \mathcal{F} and \mathcal{G} are recursive, T is recursive. An intervention do(Y=1) on T updates each row in the above left table according to its own associated function component, returning the right table. Since Y is exogenous both in \mathcal{F} and \mathcal{G} , we have $\mathcal{F}_{Y=1}=\mathcal{F}$ and $\mathcal{G}_{Y=1}=\mathcal{G}$. The value of Z in the first row of the above updated table remains unchanged, because Y is not an argument of \mathcal{F}_Z .

We list some closure properties for our logics over both causal teams and generalized causal teams in the next theorem, whose proof is left to the reader, or see [2] for the causal team case.

Theorem 2.11 Let T,S be (generalized) causal teams over some signature σ .

Empty team property: If $T^- = \emptyset$, then $T \models \varphi$.

Downward closure: If $T \models \varphi$ and $S \subseteq T$, then $S \models \varphi$.

Flatness of CO-formulas: If α is a $CO[\sigma]$ -formula, then

$$T \models \alpha \iff (\{s\}, \mathcal{F}) \models^{c} \alpha \text{ for all } s \in T^{-} \text{ (resp. } \{(s, \mathcal{F})\} \models^{g} \alpha \text{ for all } (s, \mathcal{F}) \in T).$$

The team semantics over causal teams and that over generalized causal teams with a constant function component are essentially equivalent, in the sense of the next lemma, whose proof is left to the reader.

Lemma 2.12 (i) For any causal team T, we have that $T \models^c \varphi \iff T^g \models^g \varphi$.

(ii) For any nonempty generalized causal team T with a unique function component, we have that $T \models^g \varphi \iff T^c \models^c \varphi$.

Corollary 2.13 For any set $\Delta \cup \{\alpha\}$ of $CO[\sigma]$ -formulas, $\Delta \models^g \alpha$ iff $\Delta \models^c \alpha$.

Proof. By Lemma 2.12, $\{(s,\mathcal{F})\} \models^g \beta$ iff $(\{s\},\mathcal{F}) \models^c \beta$ for any $\beta \in \Delta \cup \{\alpha\}$. Thus, the claim follows from the flatness of $\mathcal{CO}[\sigma]$ -formulas.

3 Characterizing function components

3.1 Equivalence of function components

Various notions of similarity among causal models have been considered in the literature (see e.g. [6]), which measure the "distance" between two models in terms of their empirical or counterfactual consequences. We consider here a stricter notion of equivalence, which, as we will see in theorem 3.4, characterizes indistinguishability of causal structures by means of our languages.

Consider a binary function f and an (n+2)-ary function g defined as f(X,Y) = X + Y and $g(X,Y,Z_1,\ldots,Z_n) = X + Y$. Essentially f and g are the same function: Z_1,\ldots,Z_n are dummy arguments of g. We now characterize this idea in the notion of two function components being equivalent up to dummy arguments.

Definition 3.1 Let \mathcal{F}, \mathcal{G} be two function components over $\sigma = (Dom, Ran)$.

• Let $V \in Dom$. Two functions \mathcal{F}_V and G_V are said to be equivalent up to

dummy arguments, denoted as $\mathcal{F}_V \sim \mathcal{G}_V$, if for any $\mathbf{x} \in \text{Ran}(PA_V^{\mathcal{F}} \cap PA_V^{\mathcal{G}})$, $\mathbf{y} \in \text{Ran}(PA_V^{\mathcal{F}} \setminus PA_V^{\mathcal{G}})$ and $\mathbf{z} \in \text{Ran}(PA_V^{\mathcal{G}} \setminus PA_V^{\mathcal{F}})$, we have that $\mathcal{F}_V(\mathbf{x}\mathbf{y}) = \mathcal{G}_V(\mathbf{x}\mathbf{z})$ (where we assume w.l.o.g. the shown orderings of the arguments of the functions).

Let Cn(F) denote the set of endogenous variables V of F for which F_V is a constant function, i.e., for some fixed c ∈ Ran(V), F_V(**p**) = c for all **p** ∈ PA_V^F.
We say that F and G are equivalent up to dummy arguments, denoted as F ~ G, if En(F) \ Cn(F) = En(G) \ Cn(G), and F_V ~ G_V holds for all V ∈ En(F) \ Cn(F).

It is easy to see that \sim is an equivalence relation. The next lemma shows that the relation \sim is preserved under interventions.

Lemma 3.2 For any function components $\mathcal{F}, \mathcal{G} \in \mathbb{F}_{\sigma}$ and consistent equation $\mathbf{X} = \mathbf{x}$ over σ , we have that $\mathcal{F} \sim \mathcal{G}$ implies $\mathcal{F}_{\mathbf{X}=\mathbf{x}} \sim \mathcal{G}_{\mathbf{X}=\mathbf{x}}$.

Proof. Suppose $\mathcal{F} \sim \mathcal{G}$. Then $\operatorname{En}(\mathcal{F}) \setminus \operatorname{Cn}(\mathcal{F}) = \operatorname{En}(\mathcal{G}) \setminus \operatorname{Cn}(\mathcal{G})$. Observe that $\operatorname{En}(\mathcal{F}_{X=x}) = \operatorname{En}(\mathcal{F}) \setminus X$ and $\operatorname{Cn}(\mathcal{F}_{X=x}) = \operatorname{Cn}(\mathcal{F}) \setminus X$; and similarly for \mathcal{G} . It follows that $\operatorname{En}(\mathcal{F}_{X=x}) \setminus \operatorname{Cn}(\mathcal{F}_{X=x}) = (\operatorname{En}(\mathcal{F}) \setminus \operatorname{Cn}(\mathcal{F})) \setminus X = (\operatorname{En}(\mathcal{G}) \setminus \operatorname{Cn}(\mathcal{G})) \setminus X = \operatorname{En}(\mathcal{G}_{X=x}) \setminus \operatorname{Cn}(\mathcal{G}_{X=x})$. On the other hand, for any $V \in \operatorname{En}(\mathcal{F}_{X=x}) \setminus \operatorname{Cn}(\mathcal{F}_{X=x}) = (\operatorname{En}(\mathcal{F}) \setminus \operatorname{Cn}(\mathcal{F})) \setminus X$, by the assumption, $(\mathcal{F}_{X=x})_V = \mathcal{F}_V \sim \mathcal{G}_V = (\mathcal{G}_{X=x})_V$.

We now generalize the equivalence relation \sim to the team level. Let us first consider causal teams. Two causal teams $T = (T^-, \mathcal{F})$ and $S = (S^-, \mathcal{G})$ of the same signature σ are said to be **similar**, denoted as $T \sim S$, if $\mathcal{F} \sim \mathcal{G}$. We say that T and S are **equivalent**, denoted as $T \approx S$, if $T \sim S$ and $T^- = S^-$.

Next, we turn to generalized causal teams. We call a generalized causal team T a **uniform team** if $\mathcal{F} \sim \mathcal{G}$ for all $(s,\mathcal{F}), (t,\mathcal{G}) \in T$. By Lemma 3.2, we know that if T is uniform, so is $T_{\mathbf{X}=\mathbf{x}}$, for any consistent equation $\mathbf{X} = \mathbf{x}$. For any generalized causal team T with $(t,\mathcal{F}) \in T$, write $T^{\mathcal{F}} := \{(s,\mathcal{G}) \in T \mid \mathcal{G} \sim \mathcal{F}\}$. Two generalized causal teams S and T are said to be **equivalent**, denoted as $S \approx T$, if $(S^{\mathcal{F}})^- = (T^{\mathcal{F}})^-$ for all $\mathcal{F} \in \mathbb{F}_{\sigma}$.

Theorem 3.3 (Closure under causal equivalence) *Let* T, S *be two (generalized) causal teams over* σ *such that* $T \approx S$. *We have that* $T \models \varphi \iff S \models \varphi$.

Proof. The theorem is proved by induction on φ . The case $\varphi = \mathbf{X} = \mathbf{x} \, \Box \rightarrow \psi$ follows from the fact that $T_{\mathbf{X}=\mathbf{x}} \approx S_{\mathbf{X}=\mathbf{x}}$ (Lemma 3.2). The case $\varphi = \psi \vee \chi$ for causal teams follows directly from the induction hypothesis. We now give the proof for this case for generalized causal teams. We only prove the left to right direction (the other direction is symmetric). Suppose $T \models^g \psi \vee \chi$. Then there are $T_0, T_1 \subseteq T$ such that $T = T_0 \cup T_1, T_0 \models^g \psi$ and $T_1 \models^g \chi$. Consider $S_i = \{(s, \mathcal{F}) \in S \mid \{(s, \mathcal{F})\} \approx \{(s, \mathcal{G})\} \text{ for some } (s, \mathcal{G}) \in T_i\}$ (i = 0, 1). It is easy to see that $S_i \approx T_i$ (i = 0, 1) and $S = S_0 \cup S_1$. By induction hypothesis we have that $S_0 \models^g \psi$ and $S_1 \models^g \chi$. Hence $S \models^g \psi \vee \chi$.

Thus, none of our languages can tell apart causal teams which are equivalent up to dummy arguments. However, one might not be sure, a priori, that a given argument behaves as dummy for a specific function, as this might e.g. be unfeasible to verify if the variables range over large sets. For this reason, we

are keeping this distinction in the semantics instead of quotienting it out.

3.2 Characterizing function components

For any function component \mathcal{F} over some signature σ , define a $CO[\sigma]$ -formula

$$\Phi^{\mathcal{F}} := \bigwedge_{V \in \operatorname{En}(\mathcal{F})} \eta_{\sigma}(V) \wedge \bigwedge_{V \in (\operatorname{Dom} \backslash \operatorname{En}(\mathcal{F})) \cup \operatorname{Cn}(\mathcal{F})} \xi_{\sigma}(V).$$

where
$$\eta_{\sigma}(V) := \bigwedge \{ (\mathbf{W} = \mathbf{w} \land PA_{V}^{\mathcal{F}} = \mathbf{p}) \longrightarrow V = \mathcal{F}_{V}(\mathbf{p}) \mid \mathbf{W} = \operatorname{Dom} \backslash (PA_{V}^{\mathcal{F}} \cup \{V\}), \ \mathbf{w} \in \operatorname{Ran}(\mathbf{W}), \ \mathbf{p} \in \operatorname{Ran}(PA_{V}^{\mathcal{F}}) \}$$
 and $\xi_{\sigma}(V) := \bigwedge \{ V = v \supset (\mathbf{W}_{V} = \mathbf{w} \longrightarrow V = v) \mid v \in \operatorname{Ran}(V), \mathbf{W}_{V} = \operatorname{Dom} \backslash \{V\}, \mathbf{w} \in \operatorname{Ran}(\mathbf{W}_{V}) \}.$

Intuitively, for each non-constant endogenous variable V of \mathcal{F} , the formula $\eta_{\sigma}(V)$ specifies that all assignments in the (generalized) causal team T in question behave exactly as required by the function \mathcal{F}_V . For each variable V which, according to \mathcal{F} , is exogenous or generated by a constant function, the formula $\xi_{\sigma}(V)$ states that V is not affected by interventions on other variables. If $V \in \operatorname{Cn}(\mathcal{F})$, then V has both an η_{σ} and a ξ_{σ} clause. Overall, the formula $\Phi^{\mathcal{F}}$ is satisfied in a team T if and only if every assignment in T has a function component that is \sim -equivalent to \mathcal{F} : this nontrivial fact is proved in the next theorem. This result is the crucial element for adapting the standard methods of team semantics to the causal context.

Theorem 3.4 Let σ be a signature, and $\mathcal{F} \in \mathbb{F}_{\sigma}$.

(i) For any generalized causal team T over σ , we have that

$$T \models^{g} \Phi^{\mathcal{F}} \iff for \ all \ (s, \mathcal{G}) \in T : \mathcal{G} \sim \mathcal{F}.$$

(ii) For any nonempty causal team $T = (T^-, \mathcal{G})$ over σ , we have that

$$T \models^c \Phi^{\mathcal{F}} \iff \mathcal{G} \sim \mathcal{F}.$$

Proof. (i). \Longrightarrow : Suppose $T \models^g \Phi^{\mathcal{F}}$ and $(s,\mathcal{G}) \in T$. We show $\mathcal{G} \sim \mathcal{F}$. $\operatorname{En}(\mathcal{F}) \setminus \operatorname{Cn}(\mathcal{F}) \subseteq \operatorname{En}(\mathcal{G}) \setminus \operatorname{Cn}(\mathcal{G})$: For any $V \in \operatorname{En}(\mathcal{F}) \setminus \operatorname{Cn}(\mathcal{F})$, there are distinct $\mathbf{p}, \mathbf{p}' \in \operatorname{Ran}(PA_V^{\mathcal{F}})$ such that $\mathcal{F}_V(\mathbf{p}) \neq \mathcal{F}_V(\mathbf{p}')$. Since $T \models \eta_{\sigma}(V)$, for any $\mathbf{w} \in \operatorname{Ran}(\mathbf{W})$, we have that

$$\{(s,\mathcal{G})\} \models (\mathbf{W} = \mathbf{w} \land PA_V^{\mathcal{F}} = \mathbf{p}) \ \square \rightarrow V = \mathcal{F}_V(\mathbf{p}), \\ \{(s,\mathcal{G})\} \models (\mathbf{W} = \mathbf{w} \land PA_V^{\mathcal{F}} = \mathbf{p}') \ \square \rightarrow V = \mathcal{F}_V(\mathbf{p}').$$

Thus, $s_{\mathbf{W}=\mathbf{w}\wedge PA_V^{\mathcal{T}}=\mathbf{p}}(V)=\mathcal{F}_V(\mathbf{p})\neq \mathcal{F}_V(\mathbf{p'})=s_{\mathbf{W}=\mathbf{w}\wedge PA_V^{\mathcal{T}}=\mathbf{p'}}(V).$ So, $V\notin \mathrm{Cn}(\mathcal{G}),$ and furthermore V is not exogenous (since the value of an exogenous variable is not affected by interventions on different variables). Thus, $V\in \mathrm{En}(G)\setminus \mathrm{Cn}(\mathcal{G}).$

 $\operatorname{En}(\mathcal{G}) \setminus \operatorname{Cn}(\mathcal{G}) \subseteq \operatorname{En}(\mathcal{F}) \setminus \operatorname{Cn}(\mathcal{F})$: For any $V \in \operatorname{En}(\mathcal{G}) \setminus \operatorname{Cn}(\mathcal{G})$, there are distinct $\mathbf{p}, \mathbf{p}' \in \operatorname{Ran}(PA_V^{\mathcal{G}})$ such that $\mathcal{G}_V(\mathbf{p}) \neq \mathcal{G}_V(\mathbf{p}')$. Now, if $V \notin \operatorname{En}(\mathcal{F}) \setminus \operatorname{Cn}(\mathcal{F})$, then $T \models \mathcal{E}_{\sigma}(V)$. Let v = s(V) and $\mathbf{Z} = \mathbf{W}_V \setminus PA_V^{\mathcal{G}}$. Since $\{(s, \mathcal{G})\} \models V = v$ and $V \notin PA_V^{\mathcal{G}}$, for any $\mathbf{z} \in \operatorname{Ran}(\mathbf{Z})$, we have that

$$\{(s,\mathcal{G})\} \models (\mathbf{Z} = \mathbf{z} \land PA_V^{\mathcal{G}} = \mathbf{p}) \ \square \rightarrow V = v, \\ \{(s,\mathcal{G})\} \models (\mathbf{Z} = \mathbf{z} \land PA_V^{\mathcal{G}} = \mathbf{p}') \ \square \rightarrow V = v.$$

By the definition of intervention, we must have that $v = s_{\mathbf{Z} = \mathbf{z} \wedge PA_v^{\mathcal{G}} = \mathbf{p}}(V) = \mathcal{G}_V(\mathbf{p}) \neq$

 $\mathcal{G}_V(\mathbf{p}') = s_{\mathbf{Z} = \mathbf{z} \wedge PA_{\cdot}^{\mathcal{G}} = \mathbf{p}'}(V) = v$, which is impossible. Hence, $V \in \text{En}(\mathcal{F}) \setminus \text{Cn}(\mathcal{F})$.

 $\mathcal{F}_V \sim \mathcal{G}_V$ for any $V \in \text{En}(\mathcal{F}) \setminus \text{Cn}(\mathcal{F})$: For any $\mathbf{x} \in \text{Ran}(PA_V^{\mathcal{F}} \cap PA_V^{\mathcal{G}})$, $\mathbf{y} \in \text{Ran}(PA_V^{\mathcal{F}} \setminus PA_V^{\mathcal{G}})$ and $\mathbf{z} \in \text{Ran}(PA_V^{\mathcal{G}} \setminus PA_V^{\mathcal{F}})$, since $T \models \eta_{\sigma}(V)$ and $V \notin PA_V^{\mathcal{G}}$, for any $\mathbf{w} \in \text{Ran}(\mathbf{W})$ with $\mathbf{w} \upharpoonright (PA_V^{\mathcal{G}} \setminus PA_V^{\mathcal{F}}) = \mathbf{z}$, we have that

$$\{(s,\mathcal{G})\} \models (\mathbf{W} = \mathbf{w} \land PA_V^{\mathcal{F}} = \mathbf{x}\mathbf{y}) \longrightarrow V = \mathcal{F}_V(\mathbf{x}\mathbf{y}).$$

Then $\mathcal{F}_V(\mathbf{x}\mathbf{y}) = s_{\mathbf{W} = \mathbf{w} \wedge PA_{\nu}^{\mathcal{T}} = \mathbf{x}\mathbf{y}}(V) = \mathcal{G}_V(s_{\mathbf{W} = \mathbf{w} \wedge PA_{\nu}^{\mathcal{T}} = \mathbf{x}\mathbf{y}}(PA_V^{\mathcal{G}})) = \mathcal{G}_V(\mathbf{x}\mathbf{z})$, as required.

 \Leftarrow : Suppose that $\mathcal{G} \sim \mathcal{F}$ for all $(s,\mathcal{G}) \in T$. Since the formula $\Phi^{\mathcal{F}}$ is flat, it suffices to show that $\{(s,\mathcal{G})\} \models \eta_{\sigma}(V)$ for all $V \in \text{En}(\mathcal{F})$, and $\{(s,\mathcal{G})\} \models \xi_{\sigma}(V)$ for all $V \in (\text{Dom} \setminus \text{En}(\mathcal{F})) \cup \text{Cn}(\mathcal{F})$.

For the former, take any $\mathbf{w} \in \text{Ran}(\mathbf{W})$ and $\mathbf{p} \in \text{Ran}(PA_V^{\mathcal{F}})$, and let $\mathbf{Z} = \mathbf{z}$ abbreviate $\mathbf{W} = \mathbf{w} \wedge PA_V^{\mathcal{F}} = \mathbf{p}$. We show that $\{(s_{\mathbf{Z}=\mathbf{z}}, \mathcal{G}_{\mathbf{Z}=\mathbf{z}})\} \models V = \mathcal{F}_V(\mathbf{p})$. Since $\mathcal{G} \sim \mathcal{F}$, by Lemma 3.2 we have that $\mathcal{G}_{\mathbf{Z}=\mathbf{z}} \sim \mathcal{F}_{\mathbf{Z}=\mathbf{z}}$. Thus,

$$\begin{split} s_{\mathbf{Z}=\mathbf{z}}(V) &= (\mathcal{G}_{\mathbf{Z}=\mathbf{z}})_V(s_{\mathbf{Z}=\mathbf{z}}(PA_V^{\mathcal{G}_{\mathbf{Z}=\mathbf{z}}})) \\ &= (\mathcal{F}_{\mathbf{Z}=\mathbf{z}})_V(s_{\mathbf{Z}=\mathbf{z}}(PA_V^{\mathcal{F}_{\mathbf{Z}=\mathbf{z}}})) \text{ (since } \mathcal{G}_{\mathbf{X}=\mathbf{x}} \sim \mathcal{F}_{\mathbf{X}=\mathbf{x}}) \\ &= \mathcal{F}_V(s_{\mathbf{Z}=\mathbf{z}}(PA_V^{\mathcal{F}})) \\ &= \mathcal{F}_V(\mathbf{p}). \end{split}$$

For the latter, take any $v \in \text{Ran}(V)$ and $\mathbf{w} \in \text{Ran}(\mathbf{W}_V)$. Assume that $\{(s, \mathcal{G})\} \models V = v$, i.e., s(V) = v. Since $V \notin \text{En}(\mathcal{F}) \setminus \text{Cn}(\mathcal{F})$ and $\mathcal{F} \sim \mathcal{G}$, we know that $V \notin \text{En}(\mathcal{G})$ or $V \in \text{Cn}(\mathcal{G})$. In both cases we have that $\{(s, \mathcal{G})\} \models \mathbf{W}_V = \mathbf{w} \mapsto V = v$.

(ii). Let T be a nonempty causal team. Consider its associated generalized causal team T^g . The claim then follows from Lemma 2.12 and item (i).

Corollary 3.5 For any generalized causal team T over some signature σ ,

$$T \models \bigvee_{\mathcal{F} \in \mathbb{F}_{\sigma}} \Phi^{\mathcal{F}} \iff T \text{ is uniform.}$$

The intuituionistic disjunction \mathbb{V} was shown to have the disjunction property, i.e., $\models \varphi \mathbb{V} \psi$ implies $\models \varphi$ or $\models \psi$, in propositional inquisitive logic ([5]) and propositional dependence logic ([17]). It follows immediately from Theorem 3.4 that the disjunction property of \mathbb{V} fails in the context of causal teams, because $\models^c \mathbb{V}_{\mathcal{F} \in \mathbb{F}_{\sigma}} \Phi^{\mathcal{F}}$, whereas $\not\models^c \Phi^{\mathcal{F}}$ for any $\mathcal{F} \in \mathbb{F}_{\sigma}$. Nevertheless, the intuitionistic disjunction does admit the disjunction property over generalized causal teams.

Theorem 3.6 (Disjunction property) Let Δ be a set of $CO[\sigma]$ -formulas, and φ, ψ be arbitrary formulas over σ . If $\Delta \models^g \varphi \lor \psi$, then $\Delta \models^g \varphi$ or $\Delta \models^g \psi$. In particular, if $\models^g \varphi \lor \psi$, then $\models^g \varphi$ or $\models^g \psi$.

Proof. Suppose $\Delta \not\models^g \varphi$ and $\Delta \not\models^g \psi$. Then there are two generalized causal teams T_1, T_2 such that $T_1 \models \Delta, T_2 \models \Delta, T_1 \not\models \varphi$ and $T_2 \not\models \psi$. Let $T := T_1 \cup T_2$. By flatness of Δ , we have that $T \models \Delta$. On the other hand, by downwards closure, we have that $T \not\models \varphi$ and $T \not\models \psi$, and thus $T \not\models \varphi \vee \psi$.

4 Characterizing CO

In this section, we characterize the expressive power of CO over causal teams and present a system of natural deduction for CO that is sound and complete over both causal teams and generalized causal teams.

4.1 Expressivity

In this subsection, we show that CO-formulas capture the flat class of causal teams (up to \approx -equivalence). Our result is analogous to known characterizations of flat languages in propositional team semantics ([18]), with a twist, given by the fact that only the unions of similar causal teams are reasonably defined. We define such unions as follows.

Definition 4.1 Let $S = (S^-, \mathcal{F}), T = (T^-, \mathcal{G})$ be two causal teams over the same signature σ with $S \sim T$. The union of S and T is defined as the causal team $S \cup T = (S^- \cup T^-, \mathcal{H})$ over σ , where

- $\operatorname{En}(\mathcal{H}) = (\operatorname{En}(\mathcal{F}) \setminus \operatorname{Cn}(F)) \cap (\operatorname{En}(\mathcal{G}) \setminus \operatorname{Cn}(G)),$
- and for each $V \in \text{En}(\mathcal{H})$, $PA_V^{\mathcal{H}} = PA_V^{\mathcal{F}} \cap PA_V^{\mathcal{G}}$, and $\mathcal{H}_V(\mathbf{p}) = \mathcal{F}_V(\mathbf{p}\mathbf{x})$ for any $\mathbf{p} \in PA_V^{\mathcal{F}} \cap PA_V^{\mathcal{G}}$ and $\mathbf{x} \in PA_V^{\mathcal{F}} \setminus PA_V^{\mathcal{G}}$.

Clearly, $\mathcal{H} \sim \mathcal{F} \sim \mathcal{G}$ and thus $S \cup T \sim S \sim T$.

A formula φ over σ determines a class \mathcal{K}_{φ} of causal teams defined as

$$\mathcal{K}_{\varphi} = \{T \mid T \models \varphi\}.$$

We say that a formula φ defines a class \mathcal{K} of causal teams if $\mathcal{K} = \mathcal{K}_{\varphi}$.

Definition 4.2 We say that a class K of causal teams over σ is

- causally downward closed if $T \in \mathcal{K}$ and $S \subseteq T$ imply $S \in \mathcal{K}$;
- closed under causal unions if, whenever $T_1, T_2 \in \mathcal{K}$ and $T_1 \cup T_2$ is defined, $T_1 \cup T_2 \in \mathcal{K}$;
- flat if $(T^-, \mathcal{F}) \in \mathcal{K}$ iff $(\{s\}, \mathcal{F}) \in \mathcal{K}$ for all $s \in T^-$;
- closed under equivalence if $T \in \mathcal{K}$ and $T \approx T'$ imply $T' \in \mathcal{K}$.

It is easy to verify that \mathcal{K} is flat iff \mathcal{K} is causally downward closed and closed under causal unions. Any nonempty downward closed class \mathcal{K} of causal teams over σ contains all causal teams over σ with empty team component. The class \mathcal{K}_{φ} is always nonempty as the teams with empty team component are always in \mathcal{K}_{φ} (by Theorem 2.11). By Theorems 2.11 and 3.3, if α is a CO-formula, then \mathcal{K}_{α} is flat and closed under equivalence. The main result of this section is the following characterization theorem which gives also the converse direction.

Theorem 4.3 Let K be a nonempty (finite) class of causal teams over some signature σ . Then K is definable by a $CO[\sigma]$ -formula if and only if K is flat and closed under equivalence.

In order to prove the above theorem, we introduce a CO-formula Θ^T , inspired by a similar one in [17], that defines the property "having as team component a subset of T-". For each causal team T over $\sigma = (Dom, Ran)$, define

$$\Theta^T := \bigvee_{s \in T^-} \bigwedge_{V \in \text{Dom}} V = s(V).$$

Lemma 4.4 $S \models \Theta^T$ iff $S^- \subseteq T^-$, for any causal teams S, T over σ .

Proof. " \Longrightarrow ": Suppose $S \models \Theta^T$ and $S = (S^-, \mathcal{F})$. For any $s \in S^-$, by downward

closure, we have that $(\{s\}, \mathcal{F}) \models \Theta^T$, which means that for some $t \in T^-$, $(\{s\}, \mathcal{F}) \models V = t(V)$ for all $V \in \text{Dom}$. Since $\{s\}$ and $\{t\}$ have the same signature, this implies that s = t, thereby $s \in T^-$.

" \Leftarrow ": Suppose $S^- \subseteq T^-$. Observe that $S \models \Theta^S$ and $\Theta^T = \Theta^S \vee \Theta^{T \setminus S}$. Thus, we conclude $S \models \Theta^T$ by the empty team property.

Lemma 4.5 Let $S = (S^-, \mathcal{G})$ and $T = (T^-, \mathcal{F})$ be causal teams over σ with $S^-, T^- \neq \emptyset$. Then $S \models \Theta^T \land \Phi^{\mathcal{F}} \iff S \approx R \subseteq T$ for some R over σ .

Proof. By Lemma 4.4 and Theorem 3.4, we have that $S \models \Theta^T \land \Phi^{\mathcal{F}}$ iff $S^- \subseteq T^-$ and $\mathcal{G} \sim \mathcal{F}$. It then suffices to show that the latter is equivalent to $S \approx R \subseteq T$ for some R. The right to left direction is clear; conversely, if $S^- \subseteq T^-$ and $\mathcal{G} \sim \mathcal{F}$, then we can take $R = (S^-, \mathcal{F})$.

Consider the quotient set $\mathbb{F}_{\sigma}/_{\approx}$. For each equivalence class $[\mathcal{F}] \in \mathbb{F}_{\sigma}/_{\approx}$ choose a unique representative \mathcal{F}_0 . Denote by \mathbb{F}_{σ}^0 the set of all such representatives.

Proof of Theorem 4.3. It suffices to prove the direction " \Leftarrow ". For each $\mathcal{F} \in \mathbb{F}^0_\sigma$, let $\mathcal{K}^{\mathcal{F}} := \{(T^-, \mathcal{G}) \in \mathcal{K} \mid \mathcal{G} \sim \mathcal{F}\}$. Clearly $\mathcal{K} = \bigcup_{\mathcal{F} \in \mathbb{F}^0_\sigma} \mathcal{K}^{\mathcal{F}}$. Let $T_{\mathcal{F}} = \bigcup \mathcal{K}^{\mathcal{F}}$, which is well-defined as in Definition 4.1. Since \mathcal{K} is closed under causal unions, $T_{\mathcal{F}} \in \mathcal{K}$. We may assume w.l.o.g. that $T_{\mathcal{F}} = (T_{\mathcal{F}}^-, \mathcal{F})$. Let

$$\varphi = \bigvee_{\mathcal{F} \in \mathbb{F}_{\sigma}^0} (\Theta^{T_{\mathcal{F}}} \wedge \Phi^{\mathcal{F}}).$$

It suffices to show that $\mathcal{K}_{\varphi} = \mathcal{K}$. For any $S = (S^-, \mathcal{G}) \in \mathcal{K}$, there exists $\mathcal{F} \in \mathbb{F}^0_{\sigma}$ such that $S \in \mathcal{K}^{\mathcal{F}}$. Let $R = (S^-, \mathcal{F})$. Clearly, $S \approx R \subseteq \bigcup \mathcal{K}^{\mathcal{F}} = T_{\mathcal{F}}$, which by Lemma 4.5 implies that $S \models \Theta^{T_{\mathcal{F}}} \land \Phi^{\mathcal{F}}$. Hence, $S \models \varphi$, namely $S \in \mathcal{K}_{\varphi}$.

Conversely, suppose $S = (S^-, \mathcal{G}) \in \mathcal{K}_{\varphi}$, i.e., $S \models \varphi$. Then for every $\mathcal{F} \in \mathbb{F}_{\sigma}^0$, there is $S_{\mathcal{F}} \subseteq S$ such that $S = \bigcup_{\mathcal{F} \in \mathbb{F}_{\sigma}^0} S_{\mathcal{F}}$ and $S_{\mathcal{F}} \models \Theta^{T_{\mathcal{F}}} \wedge \Phi^{\mathcal{F}}$. Thus, by Lemma 4.5, we obtain that $S_{\mathcal{F}} \approx R_{\mathcal{F}} \subseteq T_{\mathcal{F}}$ for some $R_{\mathcal{F}}$. In particular, we have that $S_{\mathcal{F}} = (S_{\mathcal{F}}^-, \mathcal{G}) \sim (T_{\mathcal{F}}^-, \mathcal{F}) = T_{\mathcal{F}}$, which gives $\mathcal{G} \sim \mathcal{F}$. But since no two distinct elements in \mathbb{F}_{σ}^0 are \sim -similar to each other, and $S_{\mathcal{F}} \sim S$ for each $\mathcal{F} \in \mathbb{F}_{\sigma}^0$, this can only happen if $S_{\mathcal{F}}^- = \emptyset$ for all $\mathcal{F} \in \mathbb{F}_{\sigma}^0$ except one. Denote this unique element of \mathbb{F}_{σ}^0 by \mathcal{H} . Now, $S = S_{\mathcal{H}} \approx R_{\mathcal{H}} \subseteq T_{\mathcal{F}} \in \mathcal{K}$. Hence we conclude that $S \in \mathcal{K}$, as \mathcal{K} is causally closed downward and closed under equivalence. \square

4.2 Deduction system

The logic $CO[\sigma]$ over (recursive) causal teams was given in [2] a sound and complete axiomatization which incorporated ideas from [7], [8], [3] and [9]. In this section, we present an equivalent system of natural deduction and show it to be sound and complete also over (recursive) generalized causal teams.

Definition 4.6 The system of natural deduction for $CO[\sigma]$ consists of the following rules:

• (Parameterized) rules for value range assumptions:

$$\frac{X = x}{V_{x \in \text{Ran}(X)} X = x} \text{ValDef}$$

$$\frac{X = x}{X \neq x'} \text{ValUnq}$$

• Rules for \land , \lor , \neg :

$$\frac{\varphi \quad \psi}{\varphi \wedge \psi} \wedge I \qquad \frac{\varphi \wedge \psi}{\varphi} \wedge E \qquad \frac{\varphi \wedge \psi}{\psi} \wedge E$$

$$[\varphi] \quad [\psi]$$

$$\frac{\varphi}{\varphi \vee \psi} \vee I \qquad \frac{\varphi}{\psi \vee \varphi} \vee I \qquad \frac{\varphi \vee \psi \quad \alpha \quad \alpha}{\alpha} \vee E$$

$$[\alpha] \qquad [\neg \alpha]$$

$$\vdots \qquad \vdots \qquad \vdots$$

$$[\neg \alpha] \qquad \vdots \qquad \vdots$$

$$\frac{\bot}{\neg \alpha} \neg I \qquad \frac{\Box}{\varphi} \quad \neg E \qquad \vdots$$

• Rules for $\square \rightarrow$:

$$\begin{array}{|c|c|c|} \hline (\mathbf{X} = \mathbf{x} \land Y = y) & \longrightarrow Y = y \\ \hline \hline (\mathbf{X} = \mathbf{x} \land Y = y) & \longrightarrow Y = y \\ \hline \hline (\mathbf{X} = \mathbf{x} \land Y = y) & \longrightarrow \bot \\ \hline (\mathbf{Y} = \mathbf{y} \land X = x \land X = x') & \longrightarrow \varphi \\ \hline (\mathbf{Y} = \mathbf{y} \land X = x \land X = x') & \longrightarrow \varphi \\ \hline (\mathbf{Y} = \mathbf{y} \land X = x \land X = x') & \longrightarrow \varphi \\ \hline (\mathbf{Y} = \mathbf{y} \land X = x \land X = x') & \longrightarrow \varphi \\ \hline (\mathbf{Y} = \mathbf{y} \land X = x \land X = x') & \longrightarrow \varphi \\ \hline (\mathbf{Y} = \mathbf{y} \land X = x \land X = x') & \longrightarrow \varphi \\ \hline (\mathbf{Y} = \mathbf{y} \land X = x & \longrightarrow \varphi & \psi \\ \hline (\mathbf{X} = \mathbf{x}) & \longrightarrow \varphi \\ \hline (\mathbf{X} = \mathbf{x}) &$$

Note that the above system is parametrized with the signature σ , and the rules with double horizontal lines are invertible. We write $\Gamma \vdash_{\sigma} \varphi$ (or simply $\Gamma \vdash_{\varphi} \varphi$ when σ is clear from the context) if the formula φ can be derived from Γ by applying the rules in the above system. It is easy to verify that all rules in our system are sound for recursive (generalized) causal teams. The axioms and rules in the Hilbert system of [2] are either included or derivable in our natural deduction system, as shown in the next proposition. We refer the reader to [2] for a commentary on the rules for $\square \to$ and a discussion of the soundness of the rule $\square \to \vee \mathsf{Dst}$ (i.e. the *Distribution* rule typical of Stalnaker's counterfactuals).

Proposition 4.7 The following are derivable in the system for $CO[\sigma]$:

- (i) $\alpha, \neg \alpha \lor \varphi \vdash \varphi \text{ (weak modus ponens)}$
- (ii) $\mathbf{X} = \mathbf{x} \longrightarrow Y = y \vdash \mathbf{X} = \mathbf{x} \longrightarrow Y \neq y'$ (Uniqueness)
- (iii) $\mathbf{X} = \mathbf{x} \longrightarrow \varphi \land \psi \vdash \mathbf{X} = \mathbf{x} \longrightarrow \varphi$ (Extraction)
- $(iv) \neg (\mathbf{X} = \mathbf{x} \square \rightarrow \alpha) \dashv \mathbf{X} = \mathbf{x} \square \rightarrow \neg \alpha$
- (v) $\bigvee_{y \in \text{Ran}(Y)} (\mathbf{X} = \mathbf{x} \longrightarrow Y = y)$ (Definiteness)

Proof. Item (i) follows from $\neg E$ and $\lor E$. Items (ii),(iii) follow from ValUnq , $\land E$ and $\Box \rightarrow \mathsf{Sub}_C$. For item (iv), the left to right direction follows from $\neg \Box \rightarrow E$. For the other direction, we first derive by applying $\Box \rightarrow \land I$, and $\Box \rightarrow \bot E$ that

$$X = x \longrightarrow \neg \alpha, X = x \longrightarrow \alpha \vdash X = x \longrightarrow \neg \alpha \land \alpha \vdash X = x \longrightarrow \bot \vdash \bot$$

Then, by $\neg I$ we conclude that $\mathbf{X} = \mathbf{x} \square \rightarrow \neg \alpha \vdash \neg (\mathbf{X} = \mathbf{x} \square \rightarrow \alpha)$.

For item (v), we first derive by $\square \to \mathsf{Eff}$ that $\vdash \mathbf{X} = \mathbf{x} \ \square \to X = x$, where X = x is an arbitrary equation from $\mathbf{X} = \mathbf{x}$. By ValDef we also have that $\vdash \bigvee_{y \in \mathsf{Ran}(Y)} Y = y$. Thus, we conclude by applying $\square \to \mathsf{Sub}_C$ that $\vdash \mathbf{X} = \mathbf{x} \ \square \to \bigvee_{y \in \mathsf{Ran}(Y)} Y = y$, which then implies that $\vdash \bigvee_{y \in \mathsf{Ran}(Y)} (\mathbf{X} = \mathbf{x} \ \square \to Y = y)$ by $\square \to \lor \mathsf{Dst}$.

Theorem 4.8 (Completeness) Let $\Delta \cup \{\alpha\}$ be a set of $CO[\sigma]$ -formulas. Then $\Delta \vdash \alpha \iff \Delta \models^{c/g} \alpha$.

Proof. Since our system derives all axioms and rules of the Hilbert system of [2], the completeness of our system over causal teams follows from that of [2]. The completeness of the system over generalized causal teams follows from the fact that $\Delta \models^c \alpha$ iff $\Delta \models^g \alpha$, given by Corollary 2.13.

5 Extensions of *CO*

5.1 Expressive power of $CO_{\mathbb{W}}$ and COD

In this section, we characterize the expressive power of $CO_{\mathbb{V}}$ and COD over causal teams. We show that both logics characterize all nonempty causally downward closed team properties up to causal equivalence, and the two logics are thus expressively equivalent. An analogous result can be obtained for generalized causal teams, but we omit it due to space limitations.

Theorem 5.1 Let K be a nonempty (finite) class of causal teams over some signature σ . Then the following are equivalent:

- (i) K is causally downward closed and closed under equivalence.
- (ii) \mathcal{K} is definable by a $CO_{\mathbb{V}}[\sigma]$ -formula.
- (iii) \mathcal{K} is definable by a $COD[\sigma]$ -formula.

By Theorems 2.11 and 3.3, for every $CO_{\mathbb{V}}[\sigma]$ - or $COD[\sigma]$ -formula φ , the set \mathcal{K}_{φ} is nonempty, causally downward closed and closed under causal equivalence. Thus items (ii) and (iii) of the above theorem imply item (i). Since dependence atoms =(**X**; **Y**) are definable in $CO_{\mathbb{V}}[\sigma]$ (see Equation (1)), item (iii) implies item (ii). It then suffices to show that item (i) implies item (iii). In this proof, we make essential use of a formula Ξ^T that resembles, in the causal setting, a

similar formula introduced in [17] in the pure team setting.

Given any causal team $T = (T^-, \mathcal{G})$ over σ , let $\overline{T} = (\mathbb{A}_{\sigma} \setminus T^-, \mathcal{G})$ and $\mathcal{G}_0 \in \mathbb{F}_{\sigma}^0$ be such that $[\mathcal{G}_0] = [\mathcal{G}]$. If $T^- \neq \emptyset$ and $|T^-| = k + 1$, define a $COD[\sigma]$ -formula

$$\Xi^T := (\chi_k \vee \Theta^{\overline{T}}) \vee \bigvee_{\mathcal{F} \in \mathbb{F}^0_{\sigma} \setminus \{\mathcal{G}_0\}} \Phi^{\mathcal{F}},$$

where the formula χ_k is defined inductively as

$$\chi_0 = \bot$$
, $\chi_1 = \bigwedge_{V \in Dom} = (V)$, and $\chi_k = \chi_1 \lor \underbrace{\cdots}_{k \text{ times}} \lor \chi_1 \ (k > 1)$.

Lemma 5.2 Let S, T be two causal teams over some signature σ with $T^- \neq \emptyset$. Then, $S \models \Xi^T \iff \text{for all } R : T \approx R \text{ implies } R \nsubseteq S$.

Proof. First, observe that the formula χ_k characterize the cardinality of causal teams S, in the sense that

$$S \models \chi_k \quad \text{iff} \quad |S^-| \le k. \tag{2}$$

Indeed, clearly, $S \models \chi_0$ iff $S^- = \emptyset$, $S \models \chi_1$ iff $|S^-| \le 1$, and for k > 1, $S \models \chi_k$ iff $S = S_1 \cup \cdots \cup S_k$ with each $S_i \models \chi_1$ iff $|S^-| \le k$.

Now we prove the lemma. Let $S = (S^-, \mathcal{H})$. " \Longrightarrow ": Suppose $S \models \Xi^T$. If $\mathcal{H} \not\vdash \mathcal{G}$, then $T = (T^-, \mathcal{G}) \approx (T^-, \mathcal{G}') = R$ implies $\mathcal{G}' \neq \mathcal{H}$, thereby $R \not\subseteq S$. Now, suppose $\mathcal{H} \sim \mathcal{G} \sim \mathcal{G}_0$. If $S^- = \emptyset$, then since $T^- \neq \emptyset$, the statement holds. If $S^- \neq \emptyset$, then by Lemma 3.4(ii), we know that no nonempty subteam of S satisfies $\bigvee_{\mathcal{F} \in \mathbb{F}_0^n \setminus \{\mathcal{G}_0\}} \Phi^{\mathcal{F}}$. Thus there exist $S_1, S_2 \subseteq S$ such that $S_1^- \cup S_2^- = S^-$,

$$S_1 \models \chi_k \text{ and } S_2 \models \Theta^{\overline{T}}.$$
 (3)

By (2), the first clause of the above implies that $|S_1^-| \le k$. Since $|T^-| = k+1 > k$, this means that $T^- \setminus S_1^- \ne \emptyset$. By Lemma 4.5, it follows from the second clause of (3) and the fact that $S_2 \models \Phi^{\mathcal{G}}$ (given again by Lemma 3.4(ii)) that $S_2 \approx R_0 \subseteq \overline{T}$ for some R_0 . Thus, $T^- \cap S_2^- = \emptyset$. Altogether, we conclude that $T^- \nsubseteq S^-$. Thus, for any R such that $R \approx T$, we must have that $R^- = T^- \nsubseteq S^-$, thereby $R \nsubseteq S$.

" \Leftarrow ": Suppose $T \approx R$ implies $R \nsubseteq S$ for all R. If $\mathcal{H} \not\vdash \mathcal{G} \sim \mathcal{G}_0$, then by Lemma 3.4(ii) we have that $S \models \bigvee_{\mathcal{F} \in \mathbb{F}^0_\sigma \setminus \{\mathcal{G}_0\}} \Phi^{\mathcal{F}}$, thereby $S \models \Xi^T$, as required. Now, suppose $\mathcal{H} \sim \mathcal{G}$. The assumption then implies that $T^- \nsubseteq S^-$. Let $S_1 = (S^- \cap T^-, \mathcal{H})$ and $S_2 = (S^- \setminus T^-, \mathcal{H})$. Clearly, $S^- = S_1^- \cup S_2^-$, and it suffices to show that (3) holds. By definition we have that $S_2^- \subseteq (\overline{T})^-$, which implies the second clause of (3) by Lemma 4.4. To prove the first clause of (3), by (2) it suffices to verify that $|S_1^-| \leq k$. Indeed, since $T^- \nsubseteq S^-$, we have that $T^- \supsetneq S^- \cap T^- = S_1^-$. Hence, $|S_1^-| < |T^-| = k+1$, namely, $|S_1^-| \leq k$.

Now we are in a position to prove the main theorem of the section.

Proof of Theorem 5.1. We prove that item (i) implies item (iii). Let \mathcal{K} be a nonempty finite class of causal teams as described in item (i). Since \mathcal{K} is nonempty and causally downward closed, all causal teams over σ with empty team component belong to \mathcal{K} . Thus, every causal team $T \in \mathbb{C}_{\sigma} \setminus \mathcal{K}$ has a nonempty team component, where \mathbb{C}_{σ} denotes the (finite) set of all causal

teams over σ . Now, define $\varphi = \bigwedge_{T \in \mathbb{C}_{\sigma} \setminus \mathcal{K}} \Xi^{T}$. We show that $\mathcal{K} = \mathcal{K}_{\varphi}$.

For any $S \notin \mathcal{K}$, i.e., $S \in \mathbb{C}_{\sigma} \setminus \mathcal{K}$, since $S \subseteq S$ and $S^- \neq \emptyset$, by Lemma 5.2 we have that $S \not\models \Xi^S$. Thus $S \not\models \varphi$, i.e., $S \notin \mathcal{K}_{\varphi}$. Conversely, suppose $S \in \mathcal{K}$. Take any $T \in \mathbb{C}_{\sigma} \setminus \mathcal{K}$. If $T \approx R \subseteq S$ for some R, then since \mathcal{K} is closed under equivalence and causally closed downward, we must conclude that $T \in \mathcal{K}$, which is a contradiction. Thus, by Lemma 5.2, $S \models \Xi^T$. Hence $S \models \varphi$, i.e., $S \in \mathcal{K}_{\varphi}$. \square

5.2 Axiomatizing $CO_{\mathbb{V}}$ over generalized causal teams

In this section, we introduce a sound and complete system of natural deduction for $CO_{\mathbb{V}}[\sigma]$, which extends of the system for $CO[\sigma]$, and can also be seen as a variant of the systems for propositional dependence logics introduced in [17].

Definition 5.3 The system of natural deduction for $CO_{\mathbb{V}}[\sigma]$ consists of all rules of the system of $CO[\sigma]$ (see Definition 4.6) together with the following rules, where note that in the rules $\forall E, \neg I, \neg E, RAA$ and $\neg \Box \rightarrow I$ from Definition 4.6 the formula α ranges over $CO[\sigma]$ -formulas only:

• Additional rules for ∨:

$$\frac{\varphi \vee \psi}{\psi \vee \varphi} \vee \mathsf{Com} \qquad \frac{(\varphi \vee \psi) \vee \chi}{\varphi \vee (\psi \vee \chi)} \vee \mathsf{Ass} \qquad \frac{\varphi \vee \psi}{\chi \vee \psi} \vee \mathsf{Sub}$$

• Rules for \mathbb{V} :

The rules in our system are clearly sound. We now proceed to prove the completeness theorem. An important lemma for the theorem states that every $CO_{\mathbb{V}}[\sigma]$ -formula φ is provably equivalent to the \mathbb{V} -disjunction of a (finite) set of $CO[\sigma]$ -formulas. Formulas of this type are called *resolutions* of φ in [5].

Definition 5.4 Let φ be a $CO_{\mathbb{V}}[\sigma]$ -formula. Define the set $\mathcal{R}(\varphi)$ of its **resolutions** inductively as follows:

- $\Re(X = x) = \{X = x\},\$
- $\mathcal{R}(\neg \alpha) = \{\neg \alpha\},$
- $\mathcal{R}(\psi \wedge \chi) = \{\alpha \wedge \beta \mid \alpha \in \mathcal{R}(\psi), \beta \in \mathcal{R}(\chi)\},\$
- $\mathcal{R}(\psi \vee \chi) = \{\alpha \vee \beta \mid \alpha \in \mathcal{R}(\psi), \beta \in \mathcal{R}(\chi)\},\$
- $\mathcal{R}(\psi \vee \chi) = \mathcal{R}(\psi) \cup \mathcal{R}(\chi)$,

•
$$\mathcal{R}(\mathbf{X} = \mathbf{x} \square \rightarrow \varphi) = {\mathbf{X} = \mathbf{x} \square \rightarrow \alpha \mid \alpha \in \mathcal{R}(\varphi)}.$$

The set $\mathcal{R}(\varphi)$ is clearly a finite set of $\mathcal{CO}[\sigma]$ -formulas.

Lemma 5.5 For any formula $\varphi \in CO_{\mathbb{V}}[\sigma]$, we have that $\varphi + \mathbb{V} \mathcal{R}(\varphi)$.

Proof. We prove the lemma by induction on φ . If φ is X = x or $\neg \alpha$ for some $CO[\sigma]$ -formula α , then $\mathcal{R}(\varphi) = \{\varphi\}$, and $\varphi \dashv \vdash \bigvee \mathcal{R}(\varphi)$ holds trivially.

Now, suppose $\psi \dashv \vdash \bigvee \mathcal{R}(\psi)$ and $\chi \dashv \vdash \bigvee \mathcal{R}(\chi)$. If $\varphi = \psi \land \chi$, observing that $\theta_0 \land (\theta_1 \lor \theta_2) \dashv \vdash (\theta_0 \land \theta_1) \lor (\theta_0 \land \theta_2)$ (by $\lor \mathsf{E}, \lor \mathsf{I}, \land \mathsf{I}, \land \mathsf{E}$), we derive by $\lor \mathsf{I}, \lor \mathsf{E}$ that

$$\psi \wedge \chi \dashv \vdash (\bigvee \mathcal{R}(\psi)) \wedge (\bigvee \mathcal{R}(\chi)) \dashv \vdash \bigvee \{\alpha \wedge \beta \mid \alpha \in \mathcal{R}(\psi), \beta \in \mathcal{R}(\chi)\} \dashv \vdash \bigvee \mathcal{R}(\psi \wedge \chi).$$

If $\varphi = \psi \vee \chi$, we have analogous derivations using the fact that $\theta_0 \vee (\theta_1 \vee \theta_2) \dashv (\theta_0 \vee \theta_1) \vee (\theta_0 \vee \theta_2)$ (by $\vee \vee \mathsf{Dst}, \vee \mathsf{I}, \vee \mathsf{E}$ and $\vee \mathsf{Sub}$) and $\vee \mathsf{I}, \vee \mathsf{E}$.

If $\varphi = \psi \vee \chi$, then by applying $\vee \mathsf{I}$ and $\vee \mathsf{E}$, we have that

$$\psi \vee \chi \dashv \vdash (\bigvee \mathcal{R}(\psi)) \vee (\bigvee \mathcal{R}(\chi)) \dashv \vdash \bigvee (\mathcal{R}(\psi) \cup \mathcal{R}(\chi)) \dashv \vdash \bigvee \mathcal{R}(\psi \vee \chi).$$

If
$$\varphi = \mathbf{X} = \mathbf{x} \longrightarrow \psi$$
, then

Theorem 5.6 (Completeness) Let $\Gamma \cup \{\psi\}$ be a set of $CO_{\mathbb{V}}[\sigma]$ -formulas. Then $\Gamma \vdash \psi \iff \Gamma \models^{g} \psi$.

Proof. We prove the " \Leftarrow " direction. Observe that there are only finitely many classes of causal teams of signature σ . Thus, any set of $CO_{\mathbb{V}}[\sigma]$ -formulas is equivalent to a single $CO_{\mathbb{V}}[\sigma]$ -formula, and it then suffices to prove the statement for $\Gamma = \{\varphi\}$.

Now suppose $\varphi \models \psi$. Then by Lemma 5.5 and soundness we have that $\bigvee \mathcal{R}(\varphi) \models \bigvee \mathcal{R}(\psi)$. Thus, for every $\gamma \in \mathcal{R}(\varphi)$, $\gamma \models^g \bigvee \mathcal{R}(\psi)$, which further implies, by Lemma 3.6, that there is an $\alpha_{\gamma} \in \mathcal{R}(\psi)$ such that $\gamma \models \alpha_{\gamma}$. Since γ, α_{γ} are $CO[\sigma]$ -formulas, and the system for $CO_{\mathbb{V}}[\sigma]$ extends that for $CO[\sigma]$, we obtain by the completeness theorem of $CO[\sigma]$ (Theorem 4.8) that $\gamma \vdash \alpha_{\gamma}$. Applying \mathbb{V} I and Lemma 5.5, we obtain $\gamma \vdash \bigvee \mathcal{R}(\psi) \vdash \psi$ for each $\gamma \in \mathcal{R}(\psi)$. Thus, by Lemma 5.5 and repeated applications of \mathbb{V} E, we conclude that $\varphi \vdash \bigvee \mathcal{R}(\varphi) \vdash \psi$.

5.3 Axiomatizing $CO_{\mathbb{V}}$ over causal teams

The method for the completeness proof of the previous subsection cannot be used for causal team semantics, as it makes essential use of the disjunction property of \mathbb{V} , which fails over causal teams. However, since causal teams can be regarded as a special case of generalized causal teams, all the rules in the system for $CO_{\mathbb{V}}$ over generalized causal teams are also sound over causal teams. We can then axiomatize $CO_{\mathbb{V}}$ over causal teams by extending the system of $CO_{\mathbb{V}}$ for generalized causal teams with an axiom characterizing the property of being uniform, i.e. "indistinguishable" from a causal team.

Definition 5.7 The system for $CO_{\mathbb{V}}[\sigma]$ over causal teams consists of all rules

of $CO_{\mathbb{V}}[\sigma]$ over generalized causal teams (Def. 5.3) plus the following axiom:

$$\overline{\bigvee_{\mathcal{F} \in \mathbb{F}_{\sigma}} \Phi^{\mathcal{F}}}$$
 Unf

By Theorem 3.4(ii), the axiom Unf is clearly sound over causal teams.

 $\mathbf{Lemma~5.8~}\textit{For any set}~\Gamma \cup \{\psi\}~\textit{of $CO_{\mathbb{V}}[\sigma]$-formulas,}~\Gamma \models^{c} \psi~\textit{iff}~\Gamma, \bigvee_{\mathcal{F} \in \mathbb{F}_{\sigma}} \Phi^{\mathcal{F}} \models^{g} \psi.$

Proof. \Leftarrow : Suppose $T \models^c \Gamma$ for some causal team T. Consider the generalized causal team T^g generated by T. By Lemma 2.12, $T^g \models^g \Gamma$. Since T^g is uniform, Corollary 3.5 gives that $T^g \models^g \bigvee_{\mathcal{F} \in \mathbb{F}_\sigma} \Phi^{\mathcal{F}}$. Then, by assumption, we obtain that $T^g \models^g \psi$, which, by Lemma 2.12 again, implies that $T \models^c \psi$.

 \Longrightarrow : Suppose $T \models^g \Gamma$ and $T \models^g \bigvee_{\mathcal{F} \in \mathbb{F}_\sigma} \Phi^{\mathcal{F}}$ for some generalized causal team T. By Corollary 3.5 we know that T is uniform. Pick $(t, \mathcal{F}) \in T$. Consider the generalized causal team $S = \{(s, \mathcal{F}) \mid s \in T^-\}$. Observe that $T \approx S$. Thus, by Theorem 3.3, we have that $S \models^g \Gamma$, which further implies, by Lemma 2.12(ii), that $S^c \models^c \Gamma$. Hence, by the assumption we conclude that $S^c \models^c \psi$. Finally, by applying Lemma 2.12(ii) and Theorem 3.3 again, we obtain $T \models^g \psi$.

Theorem 5.9 (Completeness) Let $\Gamma \cup \{\psi\}$ be a set of $CO_{\mathbb{V}}[\sigma]$ -formulas. Then $\Gamma \models^{c} \psi \iff \Gamma \vdash^{c} \psi$.

Proof. Suppose $\Gamma \models^c \psi$. By Lemma 5.8, we have that Γ , $\bigvee_{\mathcal{F} \in \mathbb{F}_{\sigma}} \Phi^{\mathcal{F}} \models^g \psi$, which implies that Γ , $\bigvee_{\mathcal{F} \in \mathbb{F}_{\sigma}} \Phi^{\mathcal{F}} \vdash \psi$, by the completeness theorem (5.6) of the system for $CO_{\mathbb{V}}[\sigma]$ over generalized causal teams. Thus, $\Gamma \vdash \psi$ by axiom Unf.

5.4 Axiomatizing COD

We briefly sketch the analogous axiomatization results for the language COD over both semantics.

Over generalized causal teams, the system for $\mathcal{COD}[\sigma]$ consists of all the rules of the system for $\mathcal{CO}[\sigma]$ (Definition 4.6) together with $\vee \mathsf{Com}$, $\vee \mathsf{Ass}$, $\vee \mathsf{Sub}$ (the "additional rules for \vee " from Definition 5.3) and the new rules for dependence atoms defined below:

$$\begin{array}{c} X = x \\ = (X) \end{array} \mathsf{Depl}_0 \\ \forall x \in Ran(X) \\ [\varphi[X = x/ = (X)]] \\ \vdots \\ \varphi \qquad \psi \quad \mathsf{Dep}_0 \mathsf{E} \ (*) \\ \end{array} \begin{array}{c} [=(X_1)] \qquad \dots \qquad [=(X_n)] \\ \vdots \\ =(X_1, \dots, X_n; Y) \\ \hline =(X_1, \dots, X_n; Y) \qquad \mathsf{Depl} \\ \hline =(X_1, \dots, X_n; Y) \qquad =(X_1) \dots =(X_n) \\ \hline =(Y) \\ \end{array} \mathsf{DepE}$$

(*) $\varphi[X=x/=(X)]$ stands for the formula obtained by replacing a specific occurrence of =(X) in φ with X=x.

These rules for dependence atoms generalize the corresponding rules in the pure team setting as introduced in [17]. The completeness theorem of the system can be proved by generalizing the corresponding arguments in [17]. Analogously to the case for $CO_{\mathbb{N}}$, in this proof we use the fact that every formula φ is (semantically) equivalent to a formula $\bigvee_{i\in I}\alpha_i$ in disjunctive normal form, where each α_i is a $CO[\sigma]$ -formula obtained from φ by replacing every dependence atom $=(\mathbf{X};Y)$ by a formula $\bigvee_{\mathbf{x}\in\mathrm{Ran}(\mathbf{X})}(\mathbf{X}=\mathbf{x}\wedge Y=y)$ with y ranging over all of $\mathrm{Ran}(Y)$. The disjunctive formula $\bigvee_{i\in I}\alpha_i$ is not in the language of $CO\mathcal{D}$, but we can prove in the system of $CO\mathcal{D}$ (by applying the additional rules in the table above) that $\alpha_i \vdash \varphi$ ($i \in I$), and that

$$\Gamma, \alpha_i \vdash \psi \text{ for all } i \in I \Longrightarrow \Gamma, \varphi \vdash \psi.$$

These mean in effect that " $\varphi \dashv \vdash \bigvee_{i \in I} \alpha_i$ ". The completeness theorem for COD is then proved using essentially the same strategy as that for $CO_{\mathbb{V}}$ (Thm. 5.6).

Over causal teams, using the same method as in the previous section, the complete system for $COD[\sigma]$ can be defined as an extension of the above generalized causal team system with two additional axioms 1Fun and NoMix:

$$\frac{\displaystyle \bigwedge_{V\in \mathrm{Dom}} \left(\beta_{\mathrm{En}}(V)\supset (\bigwedge_{\mathbf{w}\in\mathbf{W}_{V}}\mathbf{W}_{V}=\mathbf{w}\ \square\rightarrow=(V))\right)}{\displaystyle \bigwedge_{V\in \mathrm{Dom}} \left\{\Xi_{*}^{[a,b]}\mid (a,b)\in\mathbb{S}\oplus\mathbb{m}_{\sigma}^{2},\ \{a\}\models\beta_{\mathrm{En}}(V),\ \{b\}\not\models\beta_{\mathrm{En}}(V)\}\right\}} \qquad \qquad \mathsf{NoMix}\ (2)$$

$$(1)\ \mathbf{W}_{V}=\mathrm{Dom}\setminus\{V\},\ \mathrm{and}\ \beta_{\mathrm{En}}(V):=\bigvee_{X\in\mathbf{W}_{V}}\beta_{\mathrm{DC}}(X,V),\ \mathrm{where}\ \mathrm{each}\ \beta_{\mathrm{DC}}(X,V)\ \mathrm{is}\ \mathrm{the}\ \mathit{CO}[\sigma]-$$
formula from [2] expressing the property "X is a direct cause of V":
$$\beta_{\mathrm{DC}}(X,V):=\bigvee_{\{(\mathbf{Z}=\mathbf{z}\land X=x)\ \square\rightarrow V=v,\ (\mathbf{Z}=\mathbf{z}\land X=x')\ \square\rightarrow V=v'}\\ \mid x,x'\in\mathrm{Ran}(X),\ v,v'\in\mathrm{Ran}(V),\ \mathbf{Z}=\mathrm{Dom}\setminus\{X,V\},\ \mathbf{z}\in\mathrm{Ran}(\mathbf{Z}),\ x\neq x',v\neq v'\}.$$

$$(2)\ \Xi_{*}^{[a,b]}\ \mathrm{is}\ \mathrm{defined}\ \mathrm{otherwise}\ \mathrm{the}\ \mathrm{same}\ \mathrm{as}\ \Xi^{[a,b]}\ \mathrm{except}\ \mathrm{that}\ \chi_{1}\ \mathrm{is}\ \mathrm{redefined}\ \mathrm{as}$$

$$\chi_{1}:=\bigwedge_{V\in\mathrm{Dom}}\left(=(V)\land\bigwedge_{\mathbf{w}\in\mathrm{Ran}(\mathbf{W}_{V})}(\mathbf{W}_{V}=\mathbf{w}\ \square\rightarrow=(V))\right).$$

The axiom 1Fun states that the endogenous variables are governed by a unique function; the axiom NoMix guarantees that all members of the generalized causal team agree on what is the set of endogenous variables. Together, these two additional axioms characterize the *uniformity* of the generalized causal team in question (or they are equivalent to the formula Unf in $CO_{\mathbb{V}}[\sigma]$), thus allow for a completeness proof along the lines of Section 5.3.

6 Conclusion

We have answered the main questions concerning the expressive power and the existence of deduction calculi for the languages that were proposed in [1] and [2], and which involve both (interventionist) counterfactuals and (contingent) dependencies. In the process, we have introduced a generalized causal team semantics, for which we have also provided natural deduction calculi. We point out that our calculi are sound only for *recursive* systems, i.e., when

the causal graph is acyclic. The general case (and special cases such as the "Lewisian" systems considered in [19]) will require a separate study. We point out, however, that each of our deduction systems can be adapted to the case of *unique-solution* (possibly generalized) causal teams by replacing the Recurrule with an inference rule that expresses the *Reversibility* axiom from [7].

Our work shows that many methodologies developed in the literature on team semantics can be adapted to the generalized semantics and, to a lesser extent, to causal team semantics. On the other hand, a number of peculiarities emerged that set apart these semantic frameworks from the usual team semantics: for example, the failure of the disjunction property over causal teams. We believe the present work may provide guidelines for the investigation of further notions of dependence and causation in causal team semantics and its variants.
